

## **NG Owners Club - Member Location Sharing Consent and Disclaimer Form**

### **Introduction**

As part of the NG Owners Club's efforts to enhance the community and allow members to connect with each other, we are creating an approximate member location map, which will display the general locations of consenting members based on their postcodes. This information will be shared via a Google map layer and a static image on our private website and Facebook group. Participation in this map is entirely voluntary, and members may choose to opt in or opt out at any time.

To comply with applicable laws and regulations, including the General Data Protection Regulation (GDPR), and to protect the interests of both members and the club, we require your consent and agreement to the terms outlined below.

### **Consent to Share Information**

By signing this form, I, the undersigned member, hereby agree to share the following information for the purpose of displaying my approximate location on the NG Owners Club member map:

1. Postcode: Only the first part of my postcode (e.g., AB12) or an altered version of my postcode (e.g., without the last number) will be used to ensure my location is not pinpointed exactly. The data pin will only show my membership number. I understand that this will display my general area on a publicly available Google map layer and/or a static map on the club's private website and Facebook group.
2. Duration of Consent: I understand that I may withdraw my consent at any time by contacting Bob Morrison (rmorri1847@aol.com), and my location will be removed from the map within 7 days from the date of my request.

### **Data Protection and GDPR Compliance**

The NG Owners Club will handle all personal data in compliance with the General Data Protection Regulation (GDPR). The club will ensure:

Personal data shared will be limited to that which is agreed by me and will only be used for the purpose described above.

My personal data will not be shared with any third parties without my prior consent, except as required by law.

I have the right to access, correct, or request the deletion of any personal data held by the club at any time.

I acknowledge that I have been informed of my rights under the GDPR, including the right to lodge a complaint with a supervisory authority if I believe my data has been mishandled.

### **Insurance Confirmation**

By participating in this map, I confirm that I have reviewed my own insurance policies and have determined that sharing my approximate location for this purpose does not breach any of the terms of my insurance policy.

I acknowledge that the NG Owners Club is not responsible for any consequences, including any insurance disputes, arising from my participation in this initiative.

### **Liability Waiver**

I agree to waive any claims or liability against the NG Owners Club, its officers, members, or agents that may arise from the sharing of my approximate location on the member map, including but not limited to:

1. Data Misuse: I understand that while the club will take reasonable steps to safeguard my information, the use of Google Maps and online platforms carries inherent privacy risks, and the club cannot guarantee complete security.

2. Third-Party Actions: I acknowledge that the club is not responsible for any third-party actions that may result from my location being shared, including but not limited to unsolicited contact or other potential misuse of the information.

### **Opt-Out and Data Removal Process**

I understand that I may opt out of this initiative at any time by notifying Bob Morrison, [rmorri1847@aol.com](mailto:rmorri1847@aol.com), and the club will remove my information from the map within 7 days. No further data will be shared after this removal, but I understand that any static images previously shared may remain online for an extended period.
